WHEREAS, the recognition was granted to the institution namely Himgiri Nabh Vishwavidhyalaya, Village-Shishonabara, Block-Sahaspur, Post Office-Selakui, District-Dehradun, Uttarakhand for conducting B.Ed. course of one-year duration with an annual intake of 100 students vide Order No. F.NRC/NCTE/F-7/UR-78/13146 dated 29.12.2006 followed by revised recognition order for B.Ed. course of two-year duration with annual intake of 100 students vide Order No. NRC/NCTE/UR-78/2015/112860-65 dated 06.06.2015

- AND WHEREAS, the matter was placed before NRC in its 212th meeting held on 28th February, 2013 and Committee decided that the institution be allowed to shift to new premises at Himgiri Zee University, Plot/ Khasra No. 36ঘ, 38क, 36ख, 38ग, 75, 76অ 38ख, 76ख, Village Sheeshambada, P.O. Sherpur, Via-Sahaspur, Dist.-Dehradun, State Uttarakhand, Pin Code-248197 vide order No. F.NRC/NCTE/UR-78/212th Meeting/2012/38683 dated 11.03.2013.
- AND WHEREAS, the University vide letter dated 16.05.2025 has requested the Northern Regional Committee to change the name of the University from Himgiri Zee University to Jigyasa University.
- AND WHEREAS, the matter was placed before NRC in its 443rd (Volume-3) Meeting held on 09th & 10th July 2025 and the Committee considered the representation of the University and decided as under:

"The Original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -

- The recognition was granted to the institution namely Himgiri Nabh Vishwavidyalaya, Dehradun, Uttarakhand for conducting B.Ed. course of one - year duration with an annual intake of 100 students vide Order dated 29.12.2006.
- The name & premises of the University was permitted to change from Himgiri Nabh Vishwavidyalaya, Dehradun, Uttarakhand to Himgiri Zee University, Plot/ Khasra No..36घ, 38 क, 36 ख़, 38 ग, 75, 76 ज 38 ख, 76 ख, Village-Sheeshambada, P.O. Sherpur, Via-Sahaspur, Dist.-Dehradun, State Uttarakhand, Pin Code-248197 for conducting B.Ed. course of two-year duration with an annual intake of 100 students vide Order dated 06/06/2015.

The University vide letter dated 16.06.2025 has requested the Northern Regional Committee to change the name of the University to offer its B.Ed. course from Himgiri Zee University to Jigyasa University. The applicant University vide Gazette Notification No. 114/XXXVI (31.12024113(lll2024 dated 16/03/2024 under provisions of the Uttarakhand Private Universities (Amendment) Acl,2024 (Uttarakhand Act No. 05 year, 2024) has been allowed by the State Government to change its name.

In view of the above, the Committee considered the matter and permitted the University to change its name from Himgiri Zee University to Jigyasa University for offering B.Ed. course from the academic session 2025-26 with an annual intake of 100 students i.e two basic units of 50 students each."

5. NOW THEREFORE, in terms of above decision of NRC, the University namely Himgiri Zee University is hereby permitted to change its name as Jigyasa University for offering B.Ed. Course with an annual intake of 100 students i.e. two basic units of 50 students each from the academic session 2025-2026.

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01,12,2014.

- AND WHEREAS, the recognition was granted by NRC to Himgiri Zee University, Plot/Khasra No. 364, 384, 36ख, 38ग, 75, 76ज, 38ख, 76ख, Village - Sheeshambada, P.O. - Sherpur, Via- Sahaspur, District - Dehradun-248197, State-Uttarakhand for B.Ed. Course vide order No.F.NRC/NCTE/F-7/UR-78/12142-12148 dated 29.12.2006. read with change of premisses vide letter No. F.NRC/NCTE/UR-78/212th meeting/2012/38683-685 dated 11.03.2013.
- AND WHEREAS, the institution Himgiri Zee University, Plot/Khasra No. 36日, 38年, 36日, 38日, 75, 76月, 38日, 76日, Village - Sheeshambada, P.O. - Sherpur, Via- Sahaspur, District - Dehradun-248197, State-Uttarakhand has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to 4. the institution fulfilling following conditions namely.
 - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional (i) infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of
 - (iii): The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to camply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Himgiri Zee University, Plot/Khasra No. 36घ, 38घ, 38घ, 75, 76ज, 38घ, 76घ, Village -Sheeshambada, P.O. - Sherpur, Via- Sahaspur, District - Dehradun-248197, State-Uttarakhand for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other negaliatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body

(University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain & update its website as per provisions of MCTE Regulations and always display following as mandatory disclosure.
 - (a) Sanctioned programmes along with annual intake in the institution.
 - (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - (c) Name of faculty members who left of joined during the last quarter.
 - (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - (e) Fee charged from students.
 - (f) Available infrastructural facilities.
 - (g) Facilities added during the last quarter.
 - (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - (i) The affidavit with enclosure submitted along with application.
 - (j) The institution shall be free to post additional relevant information, if is so desires.
 - (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
